At the commencement of the meeting, the chairman of the BoS Dr. Prashant Nargude welcomed the members and heartily expressed his sense of gratitude for their presence.

Mr. V. P. Shrangare informed members that the agenda of the meeting for the academic year 2023-24. He further on added about the department, details of activities which has conducted in, programmes offered, infrastructure facilities available for, on-going projects etc. He also briefed about the purpose behind designing the new syllabi under the status of autonomy as per UGC guidelines.

The following matters were discussed in the meeting and consequently the resolutions were passed.

Agenda-

1. To make final syllabi of F.Y.B.A Major and Minor according to the suggestions and recommendations given by NEP 2020. Also finalization of OE, SEC and VEC Titles and syllabi.

Semester I

In the concern of Semester - I: Proposed syllabi of F.Y.B.A. Major and Minor Paper entitled, Introduction to Sociology was reviewed by all the respected members. Mr. Jagadish Sasane observed that the first topic of syllabus of this paper has to be change some factors and its sequence. He also recommended some reference books for the first topic on Rising of Social Thoughts. As well some irrelative concepts removed. Dr. Shashi Mishra has endorsed some references on Nature and Scope of Sociology

Dr. Satish Sasane suggested for Basic Concepts in Sociology. Community and Type of communities, Social institutions and its functions. He underlined the above factors because these are significant for development of social thoughts in academic line-up.

Dr. Anagha Tendulkar recommended for Social Stratification. She talked about Social Stratification: Social Differences and Social Inequality, Forms of Social Stratification: Slavery, Caste and Class as well as Functions of Social Stratification. These are important concepts for understanding social reality and disparities, so Dr. Anagha suggested to that without knowing these concepts students are not able to understand entire nature of social structure.

Mr. Tulshidas Rokade suggested that syllabi also focus on Social Change. Students has to understand the process of Social Change also he recommended some books for reading on Social Change. He talked about importance of that concept as well as which factors are responsible for Social Change and What are the barriers for that.

After reviewing the syllabi of Semester I, Dr. Shashi Mishra talked about Other Elective (Sociology of Tourism), Skill Enhancement Course (Disaster Management) and Vocation Skill Course (Rural Sociology) and according to all the members of BoS that titles and syllabi is fine, so there is no need to make more corrections or changes. Thus the above Titles and Syllabi has been passed as it is proposed.

Semester II

Dr. Satish Sasane focusses title of the paper Society, Culture and Social Change. He recommended there is need to add some points such as Meaning of Society, Social Process and Man as Social Animal.

Mr. Jagadish Sasane suggested for Religion and Secularization topic. The importance of religious harmony and peace is increasing day by day in society. The religion concept is must to know every sociology student, so he highlighted on this topic.

Dr. Anagha Tendulkar talked on Social Structure and Social Institutions. She suggested to that both concepts are significant for at first year stage. Types of groups are the basics of social structure.

Mr. Tulshidas Rokade advocated that Social Change and Social Control. Agencies of social change and social control transformed itself as per the requirement of society. He advised that fourth topic should focus on social change and social control.

Afterward reviewing the syllabi of Semester II, Dr. Shashi Mishra talked about Other Elective (Sociology of Tourism), Skill Enhancement Course (Disaster Management) and Vocation Skill Course (Rural Sociology) and according to all the members of BoS that titles and syllabi is fine, so there is no need to make more corrections or changes. Thus the above Titles and Syllabi has been passed as it is proposed.

Resolution: It is resolved that the revised syllabi of F.Y.B.A. in the subject semester I and II above papers are designed by the BoS were accepted.

2. To decide upon instructional and evaluation arrangements, methods and relevant procedures. Mr. Shrangare, Chairman of the BOS in the subject Sociology informed about the existing evaluation process and semester pattern as per the University instructions/ ordinances. Based on the recommendations given by the examination committee, Mr. Shrangare, informed that let the semester pattern be continued and evaluation/ examination pattern for each subject/courses be 60:40. Thirty marks will be allotted for the Continues Internal Evaluation and 60 marks for the Semester End Examination. Thus, the nature for the Continues Internal Evaluation system for 30 marks was decided as per the following:


Mr. Shrangare extended his sincere thanks to all members for their hearty contribution and valuable advices as well as suggestions for the sake of development of the department.
