#### (6) General Terms and Conditions:

- 1. Intellectual Property in the context of this MoU shall refer to all such patents, trademarks, copyrights in respect of any hardware, software, product documentation, design document, or any other document, whether in printed or in electronic, digital or any other format which is an integral part of the hardware/software or is supplied along with such products which form the subject matter of this MoU. Intellectual Property also includes Program/Course name, material, content, methodology, assignments, question papers, educational and promotional content. whether in printed or in electronic, digital or any other format and all business data generated during the period of validity of this MoU.
- 2. The software frameworks for the delivery of iLike Credits are designed, developed and hosted/installed by MKCL. These software codes, whether compiled or un-compiled, in printed or

- 3. - 4. Any disputes arising out of this MOU shall be settled amicably through negotiations in good faith, failing which the same shall be referred to arbitration by a sole arbitrator to be appointed by the Parties with mutual consent, in accordance with the provisions of Arbitration and Conciliation Act, 1996 and subsequent amendments thereof. This clause shall survive expiration or earlier termination of this MOU. The place of arbitration shall be at Pune and shall be conducted in the English language.
- 5. This MoU shall be effective from February 08, 2024 and shall be valid unless terminated by either party, subject to renewal and mutual amendments or updation with consent by both parties.
- 6. This MoU may be terminated by both parties by mutual consent or by either party giving the other a notice in writing of three calendar months of its intention to do so, but without dishonoring any commitment entered into prior to the date of termination notice and no party shall leave its commitment unfinished which may result in tangible losses to the other party.
