Agenda No. 4: To prepare syllabi for various trades of First year B. Voc. (Degree) for consideration and approval of the Academic Council of the college

Dr. Pratap Naikwade requested Mr. Prathamesh Lingayat to give an outline of the draft syllabi prepared for the First year of B.Voc Sustainable Agri. (Degree) in Sustainable Agriculture.

Mr. Prathamesh Lingayat welcomed all members and said that the feedbacks of all stakeholdres were taken before designing the new syllabus. After he displayed feedbacks of all Satekeholders. Also he said that the sylaabus is screened according to NEP And NSQF Guidelines and the learning outcomes of the syllabus are to enable students to acquire knowledge on the importance of agriculture as well as various farming processes and practices for sustainable practices. In this regard in the first semester, the topics such as Fundamentals of Agronomy I, Paddy Farmer I, Gardener cum Nursery Raiser I, Organic Farming Concept component, Organic Farming Nutrient Management, Introduction to Gardening and practical's based on these topics are included. In addition, a project on nursery management is also included as a part of the skill component. He further said that Fundamentals of Agronomy II, Paddy Farmer II, Gardener cum Nursery Raiser II, Agricultural waste Management, Agricultural water Management, Beekeeping Technology and practical associated with these topics is a part of the curriculum of Second semester. Mr. Prathamesh Lingayat expressed his sincere thanks to industry partner Dr. Jaydev Barve, Managing Director, Nature care fertilizers.

Dr. Naikwade appealed to all esteemed members of BOS for their suggestions on the

syllabus. Mr. Jaydev Barve, Managing Director of Nature Care Fertilizers, said the entire

syllabus is well designed and covers all aspects of agriculture.

Three major courses which includes one theory and two Practical courses, two minor courses,

one Skill enhancement course, one open elective course, one Vocational skill course, One Ability

enhancement course, one Indian knowledge System Course, One Co-curricular course. For

Semester II Three major courses which include one theory and two Practical courses, two minor

theory courses and one minor practical course, one Skill enhancement course, one open elective

course, one Value education course, One Ability enhancement course, One Co-curricular course.

The 50 marks have been assigned to each GEC course and the skills assessment would be

for 50 marks each. While assigning credits to the GEC and Skill component norms of Sector

Skill Council have been followed strictly. The credits bifurcation for GEC and Skills is in the

ratio of 40:60. Number of papers and total marks assigned to each semester are eleven and 550

respectively.
