Minutes of the meeting of the Board of Studies (Commerce) held on 25th April 2019 in the Department of Commerce, ASP College, Devrukh at 11.00 a.m.

At the commencement of the meeting, the chairman of the BOS Dr. M. H. Magdum welcomed the members and heartily expressed his sense of gratitude for their presence.

Dr. M. H. Magdum iinformed members that the Hon. UGC and the University of Mumbai conferred Autonomous Status on the college w.e.f. Academic Year 2019-20 for the initial period of 10 years. He, further on, added about the department, various activities conducted in, programmes offered, infrastructure facilities available for, on-going projects etc. He, also, briefed about the purpose behind designing the new syllabi under the status of autonomy as per UGC guidelines.

Dr. Kinnary Thakkur, the subject expert, expressed the sense of gratitude towards the Hon'ble Principal, Management and the Staff and showed appreciation for giving an opportunity of being a member of the BOS.

The following matters were discussed in the meeting and, consequently, the resolutions were passed.

Agenda-

1. To review old syllabi of F.Y.B.Com according to the suggestions and recommendations given by the BoS regarding the courses of the study, academic regulations, curricula with modifications thereof with or without.

Old syllabi of F.Y.B.Com Accountancy Sem – I was reviewed in order to design new syllabi of the same. Member of BOS, Dr. Kinnary Thakkar observed that the syllabus of

Accountancy subject of F.Y.B.Com is not up to that marked students are facing lot of problems in solving Final Account topic at FY level for that one module should be introduced on Preparation of Trial Balance. She, also, suggested Hire Purchase Module should be replaced by Bank Reconciliation Statement which has practical applications in today's current scenario. Further, she suggested to conduct Practical Oriented Learning courses. In addition to that she also conferred her views regarding the commencement of bridge courses on the opening, closing and journal entries.

Regarding F.Y.B.Com's Commerce subject, there is no need to change syllabus as suggested by Mr. A. M. Kulkarni and the same is agreed by Dr. Magdum and Dr. Kinnary. Dr. Kinnary suggested that for more practical we should add surveys particularly related to Women Entrepreneurship and we should take brief report of one or two page in a group.

Mr. Vibhav Sirdesai accentuated about keeping more focus on the commencement of the tourism related courses which, in turn, serve the purpose of the employment. He, further on, added that tourism related businesses to be evolved manufacturing, artist or service related.

Resolution: It is resolved that the revised syllabi of F.Y.B.Com in the subject of Accountancy Sem – I Hire Purchase Module should be deducted in that place Bank Reconciliation Statement should be added.

2. To decide upon instructional and evaluation arrangements, methods and relevant procedures.

Dr. M. H. Magdum, Chairman of the BOS in the subject Commerce informed about the existing evaluation process and semester pattern as per the University instructions/ ordinances. Based on the recommendations given by the examination committee, Dr. M. H. Magdum informed that let the semester pattern be continued and evaluation/ examination pattern for each subject/courses be 70:30. Thirty marks will be allotted for the Continues Internal Evaluation and 70 marks for the Semester End Examination. Thus, the nature for the Continues Internal Evaluation system for 30 marks was decided as per the following:

1) Class test: 10 Marks 2) Active Participation in the class: 10 Marks 3) Live Projects / Home assignments/
