At the commencement of the meeting, the chairman of the BoS Dr. Pratap V. Naikwade welcomed the members and introduced newly appointed members since three years tenure of last BoS was completed. He told that new BoS is designed for three years (2022-2025) following UGC guidelines given for autonomous college. Dr. Naikwade expressed his gratitude towards all new members for accepting membership of BoS. He told that he is quite sure about valuable contribution of all respected members in framing and execution of Botany syllabi in the tenure.

2. Finalization of previous BOS meeting

Dr. Ranjit Bansode proposed that the minutes of the meeting held on March 31, 2022 were already sent to all BoS members by email. Further, he asked if anyone wants to say something about those minutes and appealed members to pass the same. Dr. Vinayak Kedage told that minutes of meeting are well written so can be finalized.

3. Preparedness and Implementation of NEP 2020

Dr. Naikwade addressed the meeting that National Education Policy is revolutionary initiative by government to focus quality education in changing era. So institute has to prepare for implementation of NEP 2020 from next academic year. So we have to discuss various aspects of NEP 2020 in this meeting.

Dr. Kashid told that in accordance with the NEP 2020, the UGC has formulated a new student-centric “Curriculum and Credit Framework for Undergraduate Programmes (CCFUP)” incorporating a flexible choice-based credit system, multidisciplinary approach, and multiple entry and exit options. This will facilitate students to pursue their career path by choosing the

subject/field of their interest. So we have to consider these guidelines. Dr. Ghalme discussed pattern of degree program according to NEP 2020, undergraduate degree programmes of either 3 or 4-year duration, with multiple entry and exit points and re-entry options, with appropriate certifications. Dr. Varale opined that the 4-year bachelor's degree programme is considered a preferred option since it would provide the opportunity to experience the full range of holistic and multidisciplinary education in addition to a focus on the chosen major and minors as per the choices of the student.

Dr. Gude told that in their college also they are discussing NEP 2020 but syllabus pattern is not finalized yet. Dr. Ghalme suggested that as Athalye-Sapre-Pitre College is though autonomous, is affiliated to University of Mumbai so better to wait for the guidelines from parent university regarding implementation of NEP 2020. Dr. Kedage congratulated the college for various quality initiatives by Botany department and suggested that new syllabus must be framed considering requirement from industry.

Dr. Naikwade and other all members participated in discussion on B.Sc. Botany syllabus framed by Shivaji University, Bangalore University, Garhwal University, Mangalore University, Nainital University, Guwahati University also syllabus for all universities in Uttar Pradesh.

But in conclusion all members agreed that it is better to wait for detailed guidelines from Govt. of Maharashtra and university of Mumbai for implementation of NEP 2020.

Resolution: It is unanimously resolved that after detailed guidelines from Govt. of Maharashtra and university of Mumbai, institute will prepare syllabus of B.Sc. Botany for implementation of NEP 2020.
