1. To Confirm the Minutes of the sixth BoS Meeting Held on July 06th, 2023

The lengthy discussion took place in the meeting regarding the syllabi for the Major, Minor, Open Elective Course, Ability Enhancement Course, Vocational Skill Courses and Skill Enhancement Courses.

While designing the syllabi for these courses, the department had taken care of availability of local yet worthy resources, current market scenario, and present situation of education, learners' current abilities and liabilities, interests as well as needs and financial capacity of the institute.

Ms. Anuja Gharpure suggest that android developer fundamental subject can be practical oriented so it wil be taken as Practical session there is no need of theory session

Mrs Urmila Pol suggest that there is no need of Theory of computation Paper in UG section as it came in PG section from basics and She is backed by Ms.Anuja Gharpure

Mr. R V Kulkarni suggest fundamental of algorithm also not necessary in curriculam and it is backed by Mr. Uday Bhatye and Ms.Anuja Gharpure

On that Mrs Piya More said that we will implement it in our syllabi design.

Dr. S. D. Bhoite appreciated that designed syllabus is as per NEP 2020 framework with the aim of removing rigid boundaries and creates new possibilities for students to choose and learn the subjects of their choice.

4. To discuss the Assessment Process as Suggested by the NEP 2020

Ms Poonam Bhopalkar, the chairman of the BoS reviewed suggestions from NEP 2020 regarding the assessment process, which includes a continuous assessment process, exit point credit mechanism, SGPA, CGPA, and other ways to give credits to students.

Dr. Rajanish Kamat suggested that the Academic Bank of Credits (ABC) is the first baby step taken by the government to share and transfer credits.

Ms. Piya More added that our college is also enrolled in ABC and student enrollment is in process.

Mr. Uday Bhatye expressed his gratitude towards NEP 2020 proposes a shift in the assessment of system from a system that is summative and primarily tests rote memorization skills to one that is – regular & formative, competency based, promotes learning and development through analysis, critical thinking, conceptual clarity, etc. According to the discussion, the following resolution was passed.
